# Medicaid Expansion Top Priority for Virginia Organizing

The 2013 General Assembly session began on January 9. This year, Virginia Organizing chose five primary issues to focus on during the session. These issues are Medicaid expansion, immigration, uranium mining, predatory lending, and budget and tax fairness. In addition to these five priorities, Virginia Organizing remains supportive of the efforts of other organizations to bring about a more just Virginia.

Throughout the session, Virginia Organizing will address a number of bills and our leaders and members will contact their legislators to support or oppose legislation. Chapter leaders have already spoken to their legislators in support of anti-discrimination bills, keeping the ban on uranium mining, expanding Medicaid in Virginia, and other issues of concern.

In addition to contacting legislators directly, Virginia Organizing leaders

have submitted letters to the editor and op-eds on important issues. Virginia Organizing will continue this effort year-round, not just during the legislative session!

This year, the top priority for Virginia Organizing is the expansion of Medicaid in Virginia. A recent study found that Medicaid expansion will add about 30,000 health care jobs, insure over 400,000 people who currently do not have insurance, inject billions of dollars into Virginia's economy, and cost the state less over the next six years than not expanding Medicaid.

These are just some of the more direct effects of expanding Medicaid, but there are other positive economic effects. For example, the 30,000 people employed in health care jobs will pay taxes in Virginia. They will also eat out, shop, and live here meaning that restaurants and retailers may have to hire more people to keep up with the demand.

Medicaid will also reduce the burden on our local, private hospitals, which will reduce the amount people with insurance pay for their premiums. Hospitals provide uncompensated care for people without insurance who cannot afford it, but they have to recoup some of those losses through charging more for patients who have insurance. This is known as a "hidden tax" and is estimated to be between \$1,000 and \$2,000 each year per family.

There are many economic reasons to expand Medicaid. But the arguments are not all about money. People without insurance wait before seeking care for health concerns which can lead to dangerous consequences. People with insurance seek care earlier for health concerns. Early treatment and prevention have the best health (and cost) outcomes.

If you are willing to fight with us for Medicaid expansion, will you call your legislators and ask them to expand? Will you write a letter to the editor of your local paper? Will you get your friends involved? You can make a difference in this important debate!

### **South Hampton Roads Chapter** Making a Difference

The South Hampton Roads Chapter was able to secure a unanimous decision from the Virginia Beach City Council in support of a resolution urging the Virginia General Assembly to expand Medicaid. The Chapter is also planning to participate the "Day for All People" on January 22. The day is designed to educate people from across the Commonwealth on important issues and move those people to action by visiting their legislators and discussing the issues. The Chapter will focus on Medicaid expansion, predatory lending, uranium mining, and balanced approaches to budget needs.

#### Fiscal Cliff Negotiations Not Over

The nail-biting conclusion to the socalled "fiscal cliff" negotiations left our nation with more questions than answers. Fortunately, the tax cuts were extended for low- and middlewage earners, but they were also extended for some high-wage earners. Congress chose to defer the decisions on the automatic, acrossthe-board spending cuts known as sequestration. They also did not address two other important items: the debt ceiling and the continuing resolution.

Raising the debt ceiling means that Congress is agreeing to pay back the money already borrowed and not default on the country's debt. Past considerations not to raise the debt ceiling caused our nation's credit rating to be downgraded and caused fear of further economic downturn. The debt ceiling debate was pushed back, but recently, House leadership has signaled that they will raise the debt ceiling in the short-term to prevent default.

The continuing resolution keeps the government in business while regular budget negotiations take place. If not passed, the government will shut down. Virginia Organizing remains dedicated to the best interests of all people, not just the wealthy few. We are telling Congress not to make cuts to Medicaid, Social Security or Medicare in these negotiations.
