Dear Senators Mark Warner and Tim Kaine,

For years, Virginia Organizing has been fighting to protect and strengthen Social Security. We believe Social Security is an important program that is paid for by the people and should be protected for those people who have invested so much for so many years.

We have been fighting against corporate interests and the super wealthy who would rather see this important program cut than pay even a small increase in taxes. Closing corporate tax loopholes, increasing the Social Security tax, and raising or ending the cap on wages taxed for Social Security would help resolve concerns about the program and stabilize it for the future.

We have been fighting against elected officials who do not understand what it is like to live solely on Social Security to survive. Connie Jones, a resident of Virginia Beach, knows how to live on Social Security. She lives in the most affordable apartment in the area and is frugal with her limited resources.
